

Why give to St. Mary with St. Alban?

Our numbers are growing.

We are growing, and we're being joined by more and more worshippers all the time.

Our ministry is growing.

We want this growth to continue and to offer our community even more. We have exciting future plans to foster faith and friendship all around us, as you can see in our 'Mission Action Plan'.

Our costs are also growing.

To deliver our ministry and our mission we also need to fund the basics – the essential costs of keeping our roof on, our doors open and our premises staffed.

Our income needs to grow too.

It takes £78,000 for us to meet our Common Fund obligation which provides for clergy here and across the Diocese. A further £132,000 is needed to maintain our buildings, activities and people. To cover costs and follow our mission we need an income of around £210,000.

Congregational giving is vital.

We do not receive money from the Diocese, we rely on your generosity and your giving. Every penny we receive from you will be spent on the mission of St Mary with St Alban.

What is 'Planned Giving'

Planned Giving means supporting St. Mary with St. Alban by way of a regular payment.

In addition, every £1 that you give is worth £1.25 if it is given through the Gift Aid Scheme, because it allows us to reclaim the tax paid on the money you give.

If you're a higher tax payer you can claim a personal tax benefit.

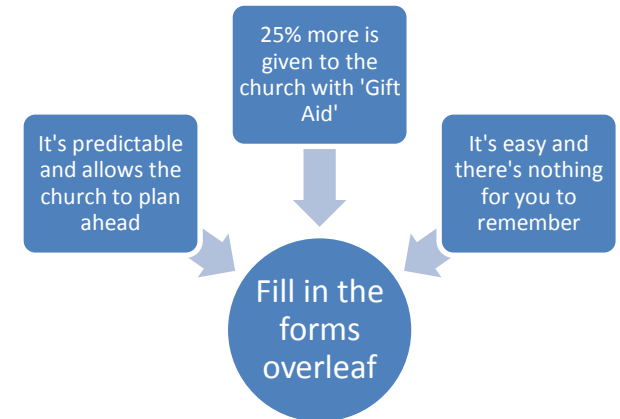
To enable us to reclaim the tax and increase the value of your gift you need to complete the Gift Aid Declaration overleaf. When signing it, please consider how you'd like to give. There are two options.

You can set up a Standing Order to St Mary with St. Alban. This means that we can budget effectively and you don't have to remember your money on Sunday morning.

Alternatively, you can join the weekly blue gift aid envelope scheme.

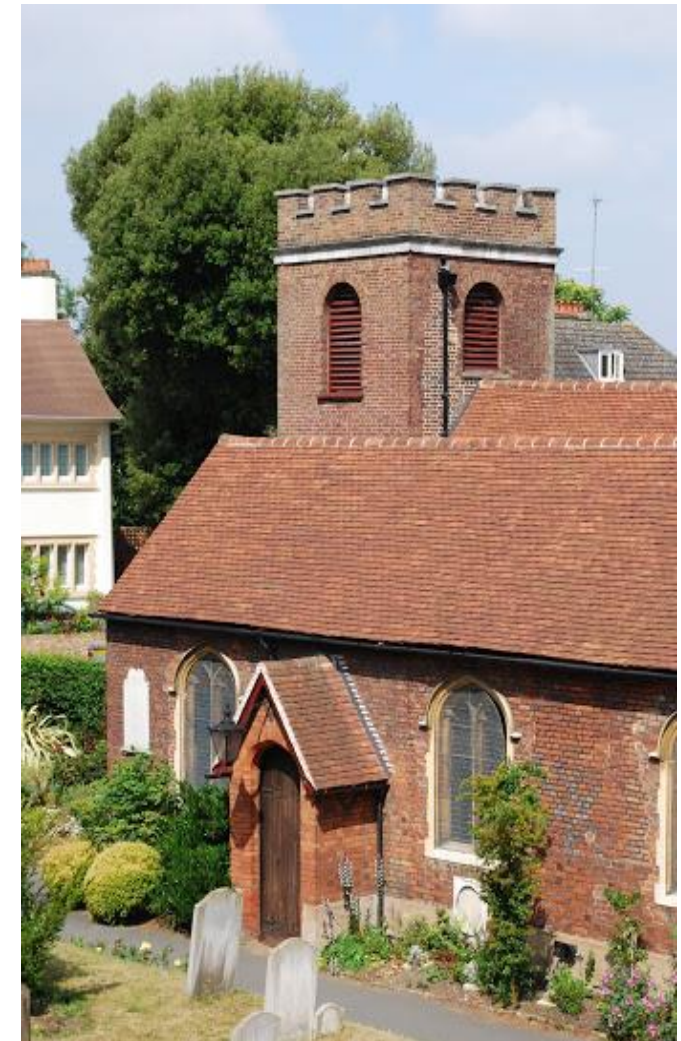
